I first met Lynette when I was a first year Resident doing a short period of anaesthetics and I recall her as a very calm, confident and kind person in her professional role, and to me who was young and inexperienced. Since I have known her through Zonta I have been impressed above all by her understated courage and determination in the face of adversity and her kindness, humor and friendship to many. Many members have relayed their thoughts and remembrances and a large group gathered to farewell her. She will be sadly missed.

I would like to congratulate the many members who contributed in diverse ways to the great success of the Trivia Night held on 7th March at Kedron. The club raised over \$5600 and it was an evening which ran very smoothly thanks to the excellent compering from Renus Burke and her son Michael, and members' input coordinated by Jenny Grant- Taylor and Glenda Gobe, and the invaluable assistance from HonZons Peter Marshall and Gary Barlow.

2015 International Women's Day

The 2015 theme for International Women's theme is *Empowering Women - Empowering Humanity: Picture It!* It again restates the dream that the women of the world will be free to choose the life they want, free from violence and discrimination. It is 20 years ago that the Beijing Declaration and Platform for Action was signed at the UN Fourth World Conference on Women. Yet as we are too sadly aware, even in the modern democracy that is Australia, much remains to be done in relation to domestic and family violence. So far in 2015, two women a week have been murdered by an intimate male partner.

At a political level in Australia, there has been much talk about violence against women and the need to eliminate it. However, budgetary constraints have led to the defunding of essential services for women at both Federal and State levels of government. In NSW for example, many refuges have closed or been unable to take women in. On one occasion the refuge in Cooma was desperate enough to want refer a woman needing help to Darwin. In Broken Hill the sole refuge will not allow women to return unless they have paid for their accommodation. Despite having one of the highest rates of domestic violence in NSW, the refuge is largely empty (Hill & Cohen, 2015).

And as we advocate to change decades of ignorance towards family violence we do so with a court system that is full of magistrates and judges who hold the same ignorant prejudices. If you are going to give lenient sentences for domestic violence, what does that say to the victim? (Rosie Battie)

Adding to the seriousness of the bedding shortages all over Australia, is the judicial system. Rosie Battie (SMH, 2015) noted that the lenient sentences handed down to perpetrators of domestic violence give the wrong message to both the victim and the perpetrator. Rosie believes that judges and magistrates hold mistaken views about the risks women face from intimate violence, and that the latter is not regarded as seriously as other violence. Additionally, no effort is made by the Court to ensure that positive behavioural change has occurred following Court-ordered anger management etc programs. This can impose a continuing risk to women.

The following is an extract from the Zonta Club manual regarding committee roles and responsibilities. The full manual is available on the website under member resources.

COMMITTEE RESPONSIBILITIES Responsibilities of the Club Committee Chairman

- Establish the goals for the committee in cooperation with the club president and club board, and aligned with Zonta's mission.
- Report to the club board and the club regularly about progress.
- · Report to the district committee chairman as required and copy the club president.
- Schedule regular meetings to discuss how committee goals will be met, with adequate notice of details, to committee members and the president and prepare an agenda.
- · Give each member of the committee some responsibility and encourage each member to contribute ideas and suggestions.
- · Adhere to the approved committee budget.
- · Work with other club committees and the club board to prepare a club calendar of events and meetings (see Section 7).

Responsibilities of the Committee Member

- · Attend committee meetings and participate in committee discussions and decisions.
- Accept assignments and responsibilities.
- Support committee projects and decisions.
