The Board:

- The Board will consist of
 - ◇ President
 - ◇ Senior Vice President
 - ◇ Junior Vice President
 - ◇ Minutes Secretary
 - ◇ Correspondence Secretary
 - ◇ Treasurer
 - ◇ Four Directors
 - ◇ Option: (1) Immediate Past President and three Directors or (2) Four Directors
- The Board will meet during the second week of each month to be decided at the AGM.
- The quorum for the Board shall be one half of Board membership plus one (six)

Annual General Meeting & Election of Officers:

- The Annual General Meeting will be held in May of each year for the purpose of election of officers, receiving the Reports of President and other Officers, Reports of Chairs of Committees and for other business that may arise.
- There will be a hand over meeting of the outgoing and incoming Board prior to the June Meeting.
